COMMITTEE OPERATIONS

At the 2018 AGM:

- Attendance numbers at the AGM were again low, with the required quorum only just being met. As noted last year, finding sufficient members with the time and inclination to stand for the Committee is an ongoing issue. This makes it doubly difficult to institute some form of succession planning for the key Committee positions, as the appropriate candidates are not coming forward.
- We farewelled Harry Burson, Steve Graham, Mike Johnston, Jed Roberts and Jared Van Eyk Menkman from last year's committee and welcomed Josh Milne, Dave Teale and Ken McClure.
- Harry had given many tears of service to the Committee, first being elected in 2003/04. He was Treasurer from 2004/05 to 2010/11. One of Harry's main interests was the standard of the grounds, and it's partly thanks to his efforts that the Club has enjoyed such good pitches. Fortunately, although not formally on the Committee, Harry continued in this role, and (we hope) for many more years to come.
- Steve Graham's departure was also a loss. He had been instrumental in managing Women's cricket in the club for the last 4-5 years, a somewhat difficult task in the face of declining player numbers.

President Tim Grocott chaired the committee meetings.

Des Haines and Glenn Bongartz from the Junior Subcommittee were invited to attend committee meetings.

PRESIDENTS REPORT

The 2018-19 season was our 113th season as a club, and we are very proud to continue providing an opportunity for people to play cricket in eastern Christchurch and further afield. However, it is becoming more challenging to do so, and the demands on our club and the members are growing. We started the season with only five adult teams and relied on two T20 teams from Shirley Boys' High School to ensure we had enough teams to maintain our Premier Club status in the Christchurch Metro competition.

Despite those challenges we continue to perform well. The Premier Men made it to the One Day Final, and won the Premiership Men Challenge Trophy; the Kings XI Punjab won the Top Four competition in Division 3; and Presidents Gold won their Top Four competition. Unfortunately, our Championship side was relegated to Division One for the coming season, and this really highlights the need to have a strong group of players below Premier Grade who are regularly available. This will be something we will aim for in the new season.

Once again, I would like to acknowledge the work of our Senior Club and Junior Club Committees. These people put in hours of voluntary work to keep our club running and without their dedication and commitment the club would not be what it is today. The Junior section continues to be strong and it was wonderful to see seven players from East Christchurch Shirley represent Canterbury at the South Island Primary School Tournament. The juniors also have fantastic club nights throughout the season, and the parents and whanau support for our club is great to see. Two members of the Junior Committee joined the Senior Committee during the season and it pleasing to have their ongoing contribution.

The Senior Committee continues to be strong, and the efforts of some of the younger members like Josh Milne as Assistant -Treasurer and Ben Hanham are very heartening for the future. It was good to see Hamish Teale get involved after being ruled out for the playing season with injury. Hamish took it upon himself to lead some fundraising initiatives, with the highlight being the Bill Duncan Memorial game. We are privileged to have Bill's grandsons playing at Easts, and they captained the two sides in a game that raised money for the club and was an enjoyable afternoon. The energy shown by Hamish is what our club is all about and he rightfully received the Grocott Trophy Presidents Award.

We continue to be well served by longstanding members, and I thank Pete Dunell, Donn Leckie, Harry Burson, Jeff Cope and John Grocott for their ongoing work. Also, a huge effort is put in by the club coach David Grocott. He spends many hours at Burwood Park ensuring the teams are full and well prepared each week. A big thank you must go to our key sponsors Alan Stroud at O'Sheas and Gareth Greenfield from Cricket Express, as well as Des Haines, Southern Business Machines; Neil Michel - KB Electrics; Dean Hanham and Heather Warne - Hanham Transport.

It is great to see the success of people associated with our club. Ken McClure, Leo Carter, Blake Coburn and Tom MacRury all played for Canterbury. We have a growing group of players involved in more senior age levels of representative cricket with Craig Gibb and Stephen Daly selected in the Canterbury Over 50's and Craig playing for New Zealand at the Over 50's World Cup. Tony Gray also represented Canterbury and New Zealand in the Over 60's age group.

It is a pleasure to serve as the President of East-Christchurch Shirley and I look forward to another year in 2019-20.

COACHING AND SELECTION

Men's Grades

Selectors

Selection

The season started with a lot of promise as the club picked up several new players for the 2018/19 season. This strengthened our Premier and 2A squad and for the first round we were able to field two very strong teams in Premiers and 2A. This was important as both teams had the threat of the new promotion/relegation environment hanging over their heads.

Tim Hampton-Matehe was re-appointed as captain for the Premier Team and Tom Dixon took over the captaincy of the 2nd Grade side. Unfortunately, Tom suffered a season ending injury and he was replaced by Jared Van Eyk Menkman after Christmas. All three did an excellent job leading their teams. While most of the Premier / 2A playing squad returned from last season the squad welcomed a number of new players: Dylan Goldstone [returned from Sydenham], Tom MacRury [from Northern Districts], Tom Gooday, Talor Scott, Dharshana Manatunga, Alex Galbraith, Myran Moore, Pankaj Kumar, Tom McDonald, Jamie Costello, Jeewan Brar, Callum Menzies, and Brad Entwistle. Veterans Tim Muir and Nick Johnston also returned for the later part of the season. The club also used three players from '*Sport Lived UK*'; Will Donsworth, Nick Mitchell and Louis Barron. *Sport Lived UK* is an organisation which arranges for young players from England to travel to NZ and experience playing cricket overseas. This is an arrangement our club hopes to foster into the future.

Despite the club being able to field two strong teams at Prems and 2A for the first few rounds, once again as the season progressed several players were lost to representative commitments, work commitments and/or injuries. We still had enough player depth in the squad to select a strong Premier team and they continued to perform well. However, this did leave our 2nd Grade team undermanned and under-gunned in what was now a very competitive grade [including the top teams from Heathcote, Merivale Papanui and Sumner]. This was not helped by a couple of 'defections' over the second half of the season. Having a consistent and strong 2nd Grade is probably the biggest issue facing the club into the near future.

The Premier and 2A teams set three performance goals at the start of the season – to make the One Day and the T20 Semi-finals, and finish in the top 4 for the Two Day competition. The Premier team achieved 2 of these goals by making the One Day final, and finishing 4th in the 2 day competition. Unfortunately, the team narrowly missed out on the T20 semi-final on net run rate after being tied on the same points with 2 other teams. Overall the season would have to be classed as a successful one for the Premier team despite not winning any 'hardware'. This team has the talent to make East Shirley continue to be a 'force to be reckoned with' into the immediate future.

The 2A team did not achieve their performance goals. There were promising signs early in the season and despite some good individual performances, they struggled as a team to 'do enough' to get regular wins. This got tougher as the season progressed and players were lost for reasons cited above. Consequently this led to a loss in confidence and performances suffered. This was disappointing as the players in this team have more ability and talent than they showed. In future, they need to show more heart and determination on a consistent basis to improve performances. Unfortunately, due to finishing last in their grade they will be relegated down a grade to Division 1. Hopefully, this will not impact on the club's ability to recruit and retain players in the coming season[s]. The club now faces the challenge of building a strong player base at the Championship grade level to enable them to win the Division 1 grade and earn promotion back into the Championship grade. I want to thank the 'regular' 2nd Grade players [and captains] who put up with continual changes to their side over the season for their patience and perseverance.

Lower grade teams were mostly 'closed teams' with the captains selecting the teams under the watchful eye of Donn Leckie.

Coaching

Coaching at the senior level of the club was mostly focussed around the Premier/2A squad. Pre-season training was held at NZ Cricket High Performance Centre at Lincoln and was well attended. A pre-season game was held against North Canterbury at Mandeville. During the season the squad trained Tuesday and Thursday nights at Burwood. We have very good practice facilities and continue to practice as hard as any club team in town.

Junior coaching was organised by Paul Cottam and the junior committee. This is largely based around parents coaching teams that their son/daughter plays in. Tom MacRury from the Premier team also helped coach some of our club's junior teams and did coaching on the Club's behalf at Shirley Boys High.

This season the East Shirley Cricket Club was required to run a 'new' Coach Mentoring, Support and Development Programme in conjunction with Christchurch Metro Cricket. This scheme was implemented by NZ Cricket. All coaches at the club were required to register and complete several online coaching modules and two practical sessions at either the Foundation or the Advanced Foundation level. This scheme was moderately successful, with some coaches struggling to complete their online modules in a timely fashion and attendance at the planned practical sessions was low. This was understandable given that this was the first time this type of programme had been tried and that parent-coaches have limited time given their work and other commitments. Improvements may need to be made for this coming season. Thirteen coaches completed the programme by the end of the season which met our club's requirements. Well done to those coaches. Thanks to Paul Cottam and Hamish Teale for their help in implementing this programme.

Congratulations

Congratulations to our Canterbury Representatives Ken McClure, Leo Carter, Blake Coburn and Tom MacRury. It is a pleasure to have you guys playing at the club and being examples for other players to follow.

Congratulations also to Tom MacRury and Talor Scott who were selected for Canterbury 'A', and to Regan Sheehan (who has played several games for the club while still being at school) who was selected for the Canterbury Under 19 Team.

Also congratulations to Tim Hampton-Matehe and Josh Milne who were named in the Christchurch Metro Premier Team of the Year at the Christchurch Metro Cricket awards evening.

It is great to see these players being recognised for their hard work and ability, as well as reflecting the talent we have in the Club. It is a testament to the 'good character' of these players that they always play for East Shirley and attend club practices whenever possible. The other squad members really appreciate the commitment and loyalty these guys show to the squad and the club overall.

PREMIERSHIP GRADE

Last season our premier team was full of promise. While we had lost key players Darren Broom and Nick Johnston from last season the team welcomed new players: Dylan Goldstone, Tom MacRury, Tom Gooday, Dharshana Manatunga, Talor Scott and Tim Muir who rejoined the team later in the season after having not played over the last couple of years. As a group, we put ourselves in positions to come out on top of games, but unfortunately couldn't always convert that passion into titles.


The One Day competition saw us finishing in 4th place in the round robin, with 4 wins and 1 game abandoned. This earned us an away semi-final against arch rivals and favourites Lancaster Park Woolston who had beaten us convincingly in the round robin game . This was a challenging game for both



sides, but an outstanding performance from our team led us to a win, landing a place in the final. The lads went into the final against our old nemesis St Albans with positivity and fire, however despite a gutsy, fighting effort we couldn't quite snatch a win, losing by 4 wickets.

The key to our good performances in the One-Day competition was the fact that we played well as a unit. There were no outstanding individuals overall but rather a group of players who all made valuable contributions to games. Tom MacRury, Tim Hampton Matehe, Talor Scott and Dylan Goldstone were the best of our batsman and Josh Milne, Ben Hanham, Tom MacRury and Tom Gooday were probably the pick of the bowlers. Ken McClure only played 2 games but in both those games he performed well with the bat

Last season's T20 format changed once again, seeing each Premier team play all the other Premier teams in the division. We had a poor start to the competition losing our first two games but gradually gathered some momentum, bagging four wins. However, we were unlucky to miss out on the semi-finals due to a marginally lower net run rate when three teams tied on the same points. This was disappointing as we would have had good



momentum going into the semi-finals. Blake Coburn was our best performed bowler taking 14 wickets and Dylan Goldstone and Ken McClure the best of our batsman.

The performances in the two-day competition were an improvement on last year although once again we finished in 4th Place. We managed three outright wins and performed more strongly against the top teams than in previous years. A good outright win over Riccarton to finish the season was a highlight. Hopefully something we can improve on in the upcoming season.

The season saw many personal successes with bat and ball. Some outstanding performances were: Tom MacRury, scoring two hundreds, one a magnificent 124 off 100 balls [including 8 sixes] against Burnside West; Josh Milne and Connor Arnold both taking a 10 wicket bag for a match; Ben Hanham grabbing his first senior 5 wicket bag, Josh Milne's season tally of 45 wickets across all formats, and Tim Hampton Matehe's 645 runs across all formats. Overall the number of 5 wickets bags and fifties by the team was higher than previous seasons.

The team has a good foundation to build on for this upcoming season. We still have a good number of players in the team with Canterbury contracts, and players involved in the Canterbury A environment, so we have plenty of talent. (Congratulations to all those players who got representative honours). With hard work and the passion all the players have, I can see this coming season producing some good performances and hopefully some titles for us.

The following article appeared in the Christchurch Metropolitan Cricket Association 2018 Annual Report. Penned by Mike Fisher, it is reproduced here as a fitting tribute to the contributions made over the years by the Grocott clan. May these long continue.

The Grocotts

The Grocott name is synonymous with both the East Christchurch Shirley Cricket Club and Christchurch cricket.

David Grocott is the older of two brothers who played from the age of six or seven. He learnt the game from his father and progressed through local schools before his secondary education started at Shirley Boys' High School. Dave was selected for the 1st XI in Year 10 as an opening batsman and played for four years in the XI. It is worth noting, given his later cricketing career, that he never bowled. He was selected in the various Canterbury rep teams from Under 14-16-18, Canterbury Brabin Shield (National Under 20) and Canterbury Kiwis.

Upon leaving school, Dave re-joined his old club at Burwood Park and initially played 2nd Grade cricket before making his senior debut against Old Collegians in 1983. Dave struggled to cement a permanent place as a batsman and it was about now that he developed his bowling as a right-arm medium pacer with prodigious in-swing and, once regaining a place in the East Shirley seniors, he made it permanent as an all-rounder's role until he retired in 1999/2000.

Some of his statistics still rate near the top of our all-time stats. He has made 137 appearances in the Metro One-day competition (3^{rd}) , has taken 148 wickets (5^{TH}) and taken 37 catches (13^{th}) , 21 wickets in a season (7^{th}) and has taken the 8th most economical spell (10-6-5-2). Clearly frugile, parsimonious, tight come to mind in describing Dave's bowling.

Upon finishing at Senior level, Dave played for two years in the Presidents Grade. In 2003 he started teaching at Shirley Boys' High School and took over coaching the 1st XI for about ten years. In 2008 he became Master-in-Charge of cricket at the school.In 2016-17 season he started coaching the East Shirley Senior team which he has really enjoyed particularly the focussed and professional approach that the players bring to their game.

Through the 1990s Dave served on the club's committee, for a period as Head of Cricket and as Treasurer.

His father, John has played a major influence on his cricket while a former coach in Ken Ferries brought an edge to his game and to the club. Fellow players in Craig Gibb and Tony Gray also helped shape the team and his attitude to the game. Son Will and daughter Grace have both played at the senior level of the East Christchurch Shirley Club in recent times.

Tim Grocott's first memories of cricket were the many hours spent playing and watching at neighbourhood Burwood Park. Under the watchful eyes of father John Grocott and David Hearn, he journeyed through the junior grades before being selected for the Shirley Boys' High School 1st XI in Year 10. Tim was a bustling medium pace out swing bowler who was part of an impressive era of his school's cricket that included Nathan Astle and

Upon leaving school, Tim returned to his former club and played 2nd Grade for East Shirley. While he made his senior debut in 1992, most of his club cricket was at the 2nd Grade level. He finished his 2nd Grade cricket in 2004-05 after his team won the One-day title for that grade after which he became a member of the East Shirley Gold Presidents team in 2006 and this team has had a dominant presence in this grade through to this day.

He served on the committee in the early 1990s as well as Teacher-in-charge of Cricket at Papanui High School. During this time Tim formed part of the drive towards the successful establishment of the North West Youth Club concept.

Over recent years Tim has served as a director of the Board of the Shirley Sports Club which administers the building that houses both Shirley rugby and cricket at Burwood Park. These post-earthquake times have provided challenges to sports clubs in Christchurch and particularly in the east where considerable depopulation has occurred.

In 2017 he became President of the East Christchurch Shirley Cricket Club and is embracing the challenge of recruiting young quality cricketers to his club. The relocation and rebuild of Shirley Boys' High School and Avonside Girls' High School to the new Queen Elizabeth II site makes for an exciting future in this regard.

Tim has been a fine servant to his club. His time is not finished in this regard and I'm sure that he will continue to add to the Grocott contribution to the club.

And now to John Grocott

What a contribution! 62 years of service to one club!

While born in Auckland, John's first recollections of cricket were watching cricket during World War II when his family resided in Richmond, Nelson. Cricket took a real grip when the family moved to Wellington with New Zealand cricketer, John Beck coaching John while at Karori Primary School. At this time John had an early cricket education from hours of throw-downs from Ivor Charles, father of the famous golfer, Sir Bob Charles. His secondary education was at Wellington College (1951-55) where he made the 1st XI in his final two years. This team, part-coached by John Reid, included Brian Hastings, one of New Zealand's foremost batsmen in the last 50 years.

In 1956, John moved to Christchurch where he played a few games for the then-Varsity Cricket Club. At this time, he came under the influence of legendary Canterbury and New Zealand cricketer, Ian Cromb, who encouraged him to join East Christchurch Cricket Club whose home ground was at Lancaster Park which they shared with the club bearing that name.

The East Christchurch club, led by its President Dr. Orchard (who held that office from 1905 to 1958!), then moved to McFarlane Park in the late 1950s before combining with the recently-established Shirley Boys' High School at Burwood Park in the 1960s. It took on the name of East Christchurch Shirley which remains to this day. John has been hugely influential in the club's development. An accountant, he was Secretary in 1957 and, for the most part, has remained on the club's committee through to the present day.

John was a delegate to the Canterbury Cricket Association in the early 1960s before becoming a Canterbury selector at Canterbury Brabin (Under 20) and Canterbury Rothmans (Under 23) level. He was then appointed to as a selector to the Canterbury Plunket Shield team in 1975-76 which won all Shell trophies available in that season. During that period, he gleaned plenty of cricket knowledge from Canterbury captain Bevan Congdon. John was re-elected after a season out and teamed up with Peter Sharp, Ian Cromb, Don McKendry and then Noel McGregor during a transitional period under the expert and influential captaincy of Maurice Ryan. It was during this period of Canterbury cricket that saw the blossoming of Canterbury great, Paul McEwan.

In the mid-1980s John returned to under-age selections again when he joined John Thompson and Wayne Wilson as Brabin selectors.

However, it is with the East Shirley club that John has made his cricketing life. He has served at varying lengths as President and Treasurer and has been involved for over six decades. John rolls club stalwarts off his tongue with great recall including David Hearn, Bill Duncan and Neil Ockwell.

But what of his influence on cricket in the east of Christchurch? John established junior cricket there in 1958 including a junior coaching programme in 1959 to 1971. It was a forerunner to the work carried out by the inspirational late Bill Duncan. He attained his Level 2 coaching grade in 1968 and in the 1980s established the Saturday morning programmes for first-year players and was the first club in New Zealand to adopt the NZC Have-a-Go programme. He has only recently retired from that programme.

In 2009-10, John was awarded the Sir Jack Newman Award for service to grass roots cricket in New Zealand.

As well as being a Life Member of his club, John was elected as a Life Member of the Christchurch Metropolitan Cricket Association in 2015.

Throughout this long service, John played for the Easts' senior team as an opening batsman from 1956 to 1981 after which he played at 2nd Grade level before fitting comfortably into the Presidents Blue team until around 2012.

Of course, his wife, Lola played a massive part in John and the family's love for the game. Elder daughter Sara played while at school and David and Tim, along with John, made for very busy Saturdays around the cricket fields and plenty of cricket lunches no doubt! John is still acting Treasurer at 85 and loves nothing more than "being there for the club", wandering around the grounds supporting the teams while reflecting on many wonderful memories that the game has brought.

And back to the beginning. There is something about the East Christchurch Shirley Cricket Club with the contributions of some recent families such as the Pawsons, Papps, Bursons and Brooms.

And leading from the front are the Grocotts; what a legacy!

CHAMPIONSHIP GRADE

The season started with some encouraging signs and in the first few Saturdays we were able to field the strongest 2A side for a couple of seasons. The Championship Grade [in which 2A played] was a much more competitive grade this season with the inclusion of the top teams from 'Suburban Clubs' (Heathcote, Merivale Papanui and Sumner), plus the number of teams in the grade being limited to eight. Ultimately, the season ended up being a very tough one for the seconds especially after Christmas when, once again, there were issues with player numbers and availabilities.

The first half of the season was mostly focussed on One Day games. While the team only won one game, that against Riccarton, there were several games where we were in the fight until the end and with a bit more luck and experience the result could have gone our way. With two more wins the team may have qualified for the semi-finals. Connor Arnold, Will Grocott, Nath McNichol and Tom Dixon were the batsmen who scored most runs in the one-dayers. Of the bowlers, Tom Dixon took the most wickets followed by Will Grocott while Connor Arnold and Nath McNicol were the most economical. During this part of the season 2A had a strong core group and I can't fault the effort from everyone.

In January we had the T20 competition where we won two games out of seven and had a close loss to Heathcote. Connor Arnold was our best performed player with both bat and ball in this competition. Youngster Regan Sheehan also performed well with the bat in the two games he played. With only two wins the team did not qualify for the semi-finals.

We finished the season by playing the remaining two-day games and it is fair to say the team lost their way over this latter part of the season. Losing Tom Dixon to injury left a big hole in the team and with the number of players unavailable at both Premier and 2A level (some due to injury), it meant there was never a settled team. Twenty-nine different players were used in the two-day competition. Unfortunately, the team lost form, confidence and 'heart' resulting in some poor performances. The situation wasn't helped by the threat of promotion/relegation hanging over the grade. Opposition teams used negative tactics by batting for too long and setting unreasonable targets for us to chase as they were not prepared to lose in case they got relegated. This attitude was disappointing and did not make the games much fun to play. Tom McDonald, Will Donsworth, and Jared Van Eyk Menkman were the highest two-day run scorers. Will Grocott, Will Donsworth, and Jared Van Eyk Menkman took the most two-day wickets.



Unfortunately, as a result of finishing bottom of the points table in the one-day and two-day competitions the team is now going to be relegated to Division 1.

Big thanks to all the players who turned out for the seconds this season, especially those guys like Alex Galbraith who came to nearly all training and was available for all games. While the results weren't favourable, I hope everyone had an enjoyable season on and off the field.

Also, a thank you to Dave Grocott for having the tough job of managing us this season, organising a team well into the night on Fridays and helping the boys at training each Tuesday and Thursday.

Hope to see everyone back for another tilt next season. Here's cheers.

After spending the previous season playing as part of a combined team with OBC - with mixed results - it was decided to try and "reform" as East Shirley Gold for the 2018/19 season. The motivation was to once again put out a team each week to compete strongly with the aim of mounting a serious challenge to win the grade. Our team manager Steve Sharman (Claw) put out the call in August and with several former OBC players from the combined team joining the club, and several players from the disbanded East Shirley Blue team becoming available, it soon became clear we had healthy depth and would be able to put together a good squad.

Unfortunately before the season started, the withdrawals of Marc Wells and Steve Woodhouse put us on the back foot, and we started poorly, with back to back losses to the two Merivale Papanui teams. Our issue through the first half of the season was a lack of runs from the top order. In fact we



averaged only 110 runs per innings up to Christmas which meant we were repeatedly relying on our bowlers to keep us in the game. On a number of occasions they delivered, which meant we fashioned a 3 win/4 loss record going into the Christmas break, that saw us sitting in the bottom half of the table, but still in contention due to the even nature of the competition.

After Christmas our top order batting clicked into gear (we averaged 190 runs per innings in the second half of the season) which meant we gave ourselves a good chance in every game, and steadily climbed the table to finish a very creditable third at the end of the double round robin, behind champions BWU and St Albans.

We then headed into the "Top 4" play off with a chance to win some silverware. Over the last month the team's form peaked and we played our best cricket of the season. On consecutive weekends we defeated St Albans, BWU and Sumner, all in tight run chases, to win the Top 4 play-offs trophy.

The undoubted highlight of the season was playing BWU on the test wicket at Hagley Oval in March. It was very satisfying to do justice to the occasion by putting in an excellent performance with bat and ball to come away with a win over a team that has dominated the competition in recent years.

As mentioned, the consistency of our bowling was a big part of our success this season, with the team only twice conceding over 200 runs. The spine of our bowling attack consisted of Tim Grocott, Steve (Arfur) Daly and Tony Gray. Capturing 77 wickets between them and all with economy rates around 3.5 rpo they enabled us to control games and exert scoreboard pressure.

Tim, despite widespread rumours he has lost a yard or two of pace, was a very consistent performer, who often bowled his 8 overs on the trot upfront, and invariably managed to remove one or two top order players. Arfur again proved he is one of the canniest bowlers in the grade, with his accuracy and variations claiming many victims. Tony had a great

season and despite missing a number of games due to injury and international commitments (NZ Over 60s team) he finished as top wicket taker at a very low average.

When he was in rhythm Duncan Clayton added bite to the attack with his left-armers delivered from height hurrying up batsmen. His regular after match craft beer contributions were much enjoyed, and some consolation for those who fell victim during his brief umpiring stints. The O'Connor brothers also added variety to the bowling attack. Jimmy was prepared to bowl anytime from either end and had a happy knack of getting wickets with his looseners. Paul was utilised opening the bowling on a number of occasions and his leg-spinners unsettled a number of opposing opening batsmen. His witty match reports on the Presidents Facebook page also attracted a good following.

Although fielding was not our strength, that was not the case behind the stumps, where Dean Iggo was outstanding with the gloves. He took a number of slick leg-side stumpings and was arguably the best keeper in the grade. In combination with his batting efforts he was deservedly voted player of the year. Paul Cottam was an able substitute behind the stumps when Dean was unavailable.

Amongst the batting, Music, Gibb, Hemingway (when available) and Iggo formed a strong top order once they hit some form after Christmas. Tom Music played a couple of match winning innings with 115 not out against Lancaster Park (out of a team total of 190), and then 91 against St Albans in the top 4 play-off game. Alan Hemingway was consistent without going on to a big score, and Arfur, Richard Cherry, Johnny Robson and Nick Bates also contributed important runs at different times.

It was good to welcome Peter Dobbs to the squad after Christmas and in his brief appearances before injury struck he showed his ex-first class pedigree with the bat. It was also pleasing to see Nobby Fletcher return late in the season after a number of years away.

Thanks go to Anne McLeod who became our regular scorer, except when she was poached by the premier team, and to Steve Sharman, our manager, who kept everything ticking over. Claw's inspirational "don't #\$&* it up" cry as we took the field each week made sure there was no complacency in the ranks.

Thanks to all the squad for your contributions on and off the field and I look forward to playing with you again next season.



Our Man at the Over-50's World Cup

In November 2018 the inaugural Over-50s World Cup was held in Sydney with eight teams competing – Australia, England, NZ, South Africa, Pakistan, Sri Lanka, Wales and Canada. Craig Gibb from our President's Gold team was selected in the New Zealand 16 man squad along with fellow Cantabrians, and Presidents grade regulars, Andrew Nuttall and Hamish Kember. The NZ squad boasted ten players with first class experience and one ex international in Richard Petrie. Similarly, most other teams included former well-performed grade cricketers or first class players, with Pakistan being particularly strong with five former internationals in their squad.

The format of the tournament was a round-robin of 45 over games followed by a semifinal and final. Games were played in coloured clothing and with a pink ball on the best grade cricket grounds in Sydney.

The New Zealand team began with narrow losses to Pakistan by 16 runs and Australia by 2 wickets. However, they then strung together a number of wins before a loss to England left them requiring a win in their last game against South Africa to make the top four. This was achieved in convincing fashion to set up a semi-final against top qualifier Australia.

Batting first, Australia posted an imposing 276. However, NZ remained up with the required rate throughout the run chase before losing wickets in the latter overs. Four to tie, or six to win, off the final ball which was dispatched high toward mid-wicket but was unfortunately caught two metres inside the boundary to give Australia the win. They went on to beat Pakistan in the final by three runs to claim the inaugural Word Cup.

Over-50s cricket is gaining momentum around the world with a county championship in England, and a state tournament in Australia. New Zealand will hold its first Interprovincial tournament in October 2019 with club members Craig Gibb and Stephen Daly selected in the Canterbury/Otago team to play at the tournament. A New Zealand squad will be selected later this year to play in the next World cup which is taking place in South Africa in March 2020 with India, West Indies, Zimbabwe and Namibia joining the eight teams that competed in 2018 to make it a truly global tournament.


....."Season of a Cricket Tragic"...

When will it stop many ask, but for me I will go on for as long as I can.

The 2018/19 season was one for me to remember. My health had been good and was clear of all afflictions. I was ready for action.

I started the season with the Presidents XI and quickly got into the groove. Our team had mixed results, but I was noticed by the powers that be and was invited to practice and play for the Canterbury Over-60s team in the tournament in February 2019.

The first problem was that I haven't practiced cricket for 20 years. The usual crew had turned up and it was a delight to meet again Hamish Wright and Rob Deans, old friends and team mates I had played with



in my first senior game back in 1978. The competitive juices were flowing and after a couple of hours, I had picked up a flexor strain on my hip at the first practice. A note for budding cricketers wanting to come back: do not push it too hard and too quickly - ease back into it. This resulted in me being very sore and not able to bat for a couple of weeks. But I could bowl and did turn up for more practice (punishment) in the following weeks.

I had put myself down for the Kindred Cricket competition in which the Willows CC had entered a team. The games were held in Wellington at the Karori CC, fortuitously on the Thursday – Saturday, with the Over-60s tournament scheduled to start on the Sunday. What wonderful grounds and set up. This was a Twenty20 series of games. There were seven other teams from around NZ with no age limitation. The first over I bowled I pulled my calf muscle (which later turned out to be the Achilles tendon). This reduced my run up to two paces. A lot of people did not see a difference. The Willows XI, captained by Sam Davis, played extremely well and we ended up winning. I was picked in the tournament XI which was an honour as this was quite a strong competition.

The Over-60s tournament has been held in Wellington over the last three years and played at the Petone Recreation ground. The tournament included teams from all the other provinces, and was split into two pools, with a final. Canterbury had been champions for the previous two years and were looking for a three-peat.

We started well against CD and scored 228/4 off our 40 overs. Batters retired at 35, so max score is 40. Phil Harris had a number of 40's and was batsman of the tournament. CD replied 170 all out. Next we played Otago and compiled a record 280 with five retirements. Otago scored not much and lost badly. Next we played ND, and we batted first and scored 229. They replied with 176. With the pools system this meant that we played ND again in the final.

We batted first and scored 221. Unfortunately, we lost the services of Danny Langrope with a back injury and he could not partake in the rest of the game. It was an exciting game with ND requiring 4 from the last ball to win. They were running the third to tie but there was a run out and we won by one run. A great result for the Cantabs.

At the presentation and dinner afterwards, I was selected for the NZ side to play in the Australia Over-60s state competition, which includes two NZ Over-60s sides. To show the strength of the competition, the State sides first have tournaments to select their representative team. NSW have over 800 players turn up for their tournament.

I was also selected for NZ Over-60s to play the touring Australian Over-60s side in late February. I played three tests against the Aussies at Queenstown, Wellington and Auckland. The Queenstown and Auckland grounds were challenging with their 80-metre boundaries. Queenstown would have to be the coldest game of cricket I have played in with a southerly coming straight up Lake Wakatipu from Kingston via Antartica. The tests were 50 over affairs with no retirements. NZ won at Queenstown but lost at Wellington. The game at Auckland was won by NZ and we won the series 2-1. They were a great bunch of players, with, I think, the umpiring favouring our side a bit.

So I came back to Presidents grade and ended up playing on Hagley oval (bloody 80metre boundaries keep following me around), and then onto Burwood No. 1 for the President's Cup final, which we won.

All in all, a very good season for me.

TREASURER'S REPORT

The financial result this year is disappointing with a substantial loss of \$10,000 recorded. Expenses are steady but income is about \$10,000 behind 2018, a reduction in grants and fundraising the main reason, despite a lot of good efforts. Thanks to the Junior Committee for their efforts and the club for their support of these activities. We need to do a lot more. Details are shown in Note 8. Thanks also to our generous supporters for their donations. The accounts are subject to audit at the time of writing.

Expenditure is reasonably consistent with the past. Coaching costs are slightly down and ground costs including the new junior pitch are up. Other costs are generally consistent with the previous year although there are some variations. Administration costs are down. Last year we wrote-off some merchandise. Pavilion running costs set by Shirley Sports Club Ltd are based on funds required to manage the clubrooms effectively. This is subject to consultation. We are in arears and will need extra fundraising in the coming season to get on top of this. Depreciation is the annual reduction in book value of our assets. This is a non-cash expense. The amount is down this year.

The statement of financial position clearly sets out the situation at balance date. The liquidity position remains weak with funds in the bank less than current liabilities. GST is a recovery, received since balance date, and inventories are down on last year. The trust reserves are on term deposit with Westpac and earn a small amount of interest. Details are shown in the notes. A small unsecured, interest free loan has been obtained to assist with liquidity. Our equity is down \$10,000 and we need to generate more income to both cover costs and recover equity. A surplus position is essential to maintain equity and cash flow as losses are not sustainable in the long run.. This is something the incoming committee will need to address.

The unaudited accounts of Shirley Sports Club Ltd are also included in the Annual Report. These show a loss after depreciation and reflect the matters regarding rents for member clubs mentioned above.

In conclusion, my thanks to the gaming trusts and Christchurch Metropolitan Cricket Assn for their support as set out in the notes. Also to Andy Innes and Gareth Greenfield of Cricket Express, Allan Stroud of O'Sheas and all others for their continued support and sponsorship. These are acknowledged in more detail elsewhere in the report. Thanks also to club members for their assistance during the year, particularly Harry Burson, Donn Leckie, Heather Warne and others with lunches, Paul Cottam and the Junior committee for the work they do collecting subs, handling hospitality activities, the fundraisers and helping with other matters. A good effort by all concerned and much appreciated.

As some may recall, Tom Dixon is officially Treasurer but for various reasons it is taking time to complete a full change-over. Tom has some involvement and I have continued to help with the accounting work in the meantime. Hopefully Tom is still available as a full change-over will be necessary for the coming season.

NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 MAY 2019

1. STATEMENT OF ACCOUNTING POLICIES

Reporting Entity

East Christchurch Shirley Cricket Club (Inc) is incorporated under the Incorporated Societies Act 1908.

Basis of Preparation

The financial reports of the East Christchurch Shirley Cricket Club (Inc) are special purpose reports prepared for the Club Management Committee and Club members.

Measurement Base

The accounting principles recognised as appropriate for the measurement and reporting of financial performance on a historical cost basis have been followed by the Club. Reliance is placed upon the fact that the Club is a going concern and that accrual accounting is used to match expenses and revenues.

Specific Accounting Policies

The following is a summary of the significant accounting policies adopted in the preparation of the financial statements.

(a) Accounts Receivable

Accounts receivable are stated at their estimated net realisable value.

(b) Inventories

Inventories are valued at the lower of cost or net realisable value, on a first-in-firstout basis.

(c) Fixed Assets

Fixed assets are stated at cost less accumulated depreciation except for playing gear which is stated at valuation. Buildings have not been revalued to the registered market valuation. Depreciation is calculated using rates considered appropriate by the Committee.

(d) Goods and Services Tax

The financial statements have been prepared on a GST exclusive basis.

(e) Liabilities

Liabilities are stated at the estimated amounts payable and include obligations which can be reliably estimated.

(f) Grants and Donations

Grant and donation income is recognised as income on receipt unless the Society has a liability to repay if the requirements of the grant or donation are not fulfilled. A

Changes in Accounting Policies

Apart from adopting the applicable new reporting requirements for incorporated societies, there have been no material changes in accounting policies. All policies have been applied on a basis consistent with those used in the previous year.

7. PAVILION REDEVELOPMENT & SHIRLEY SPORTS CLUB LIMITED

The Club entered into a Heads of Agreement and Joint Venture Agreement with the Shirley Rugby Football Club Inc. for the redevelopment of the existing pavilion in 2004. The project commenced in March 2005 and was completed in November 2005. Under the agreement, the pavilion is managed by the Shirley Sports Club Limited, a non-profit company established for this purpose. Each Club has equal shareholding and appoints three Directors. Under the agreement, "ownership" of the pavilion passed to the company at an agreed value and a notional gain on sale resulted. This was treated as an increase in member's funds in the 2006 year. During the 2015 year a further advance of \$5,000 was made and, by agreement, rent owing totalling \$27,000, net of GST, was deducted from the advance. As a result, the amount of the advance to the company was reduced. There have been no transactions of similar nature in subsequent financial years. At balance date advances made by the Club to Shirley Sports Club Limited totalled \$254,660 (last year \$254,660). The advance is interest free and repayable on demand.

The Society has related party transactions with the Shirley Sports Club Limited. In the current year the club was charged rent of \$10,000 (2018: \$10,000). This reflects the current arrangement whereby rents are determined by the directors in consultation with member clubs based on funds required to manage the company effectively. The current basis was introduced from the year commencing 1 April 2015.

During the year under review, East Christchurch Shirley Cricket Club Inc. has transactions with committee members of the Society for expenditures incurred on behalf of East Christchurch Shirley Cricket Club Inc. These transactions were on a normal commercial basis.

President, Tim Grocott, Assistant Treasurer, John Grocott and contracted club coach, David Grocott are related. During the year, David Grocott was paid \$11,900 for coaching services in accordance with the contract. (2018: \$11,900) John Grocott advanced a loan of \$2,000 (2018: \$2,000) which is interest free and repayable on demand.

NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 MARCH 2019

1. STATEMENT OF ACCOUNTING POLICIES

Reporting Entity

Shirley Sports Club Limited ("The Company") is a company registered under the Companies Act 1993. The Financial Statements of the Company are special purpose reports prepared for the Directors and Shareholders.

Accordingly, this special purpose report is not prepared in full compliance with generally accepted accounting practice (GAAP) and should not be relied upon for any other purposes or by anyone other than the Directors and Shareholders.

Measurement Base

The accounting principles recognised as appropriate for the measurement and reporting of financial performance and financial position on a historical cost basis are followed by the Company, with the exception of selected items for which specific accounting policies have been applied. Accrual accounting is used to match revenue and expenses. Reliance is placed on the fact that to company is a going concern.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied:

a) Receivables

Receivables are recognised at estimated realisable value.

b) Stocks

Stocks are recognised at the lower of cost, determined on a first-in first-out basis, and net realisable value.

c) Buildings, Plant and Equipment

Buildings, plant and equipment are recognised at cost less aggregate depreciation. Depreciation has been calculated using the maximum rates permitted by the Income Tax Act 2004.

d) Leases

The Company leases the land on which the clubrooms are situated from the Christchurch City Council. The lease is for a 20 year term and there is an automatic right of renewal (to be negotiated). Lease payments are made on an annual basis and are recognised as an expense.

e) Goods and Services Tax

The financial statements have been prepared on a GST exclusive basis.

f) Income Tax

The Company has been granted a tax exemption under Section CW 46 of the Income Tax Act 2007 and no income tax is payable.

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

2. <u>SHARE CAPITAL</u>

The Company has issued 100 ordinary shares. These are held equally by the Shirley Rugby Club Inc and the East Christchurch Shirley Cricket Club Inc. At balance date, no share capital had been called up.

All shares have equal voting rights and share equally in dividends and surplus on winding up.

3. <u>STOCKS</u>

No stocks are specifically and separately pledged as security for liabilities. Stocks are subject to retention of title clauses.

4. BUILDINGS, PLANT AND EQUIPMENT

6. ADVANCES - REDEVELOPMENT OF CLUBROOMS

The Shirley Rugby Football Club Inc (SRFC) and East Christchurch Shirley Cricket Club Inc (ECSCC) have advanced funds for the redevelopment of the Clubrooms under terms set out in a Heads of Agreement and Joint Venture Agreement. The project was completed in November 2005. The advances are interest free and technically repayable on demand. However, under the agreement, repayment in the immediate future is unlikely. During the 2015 year, a further advance of \$5,000 from each club was received and, by agreement, rents owing, net of GST, totally \$30,761 for SRFC and \$27,000 for ECSCC were deducted from the advances reducing the balance. The advances are currently - SRFC \$312,311(2017: \$312,311) and ECSCC \$254,661 (2017: \$254,661).

7. RELATED PARTY TRANSACTIONS

The Company has related party transactions with both the Shirley Rugby Football Club Inc and the East Christchurch Shirley Cricket Club Inc. By arrangement, rent of \$10,000 plus GST (2018: \$10,000) has been charged to each member club for the 2019 year. Future rents will be determined by the directors based on amounts considered appropriate by the directors to manage the company effectively. Rents have previously been based on an agreed formula. A new process for determining Board members were reimbursed for expenses incurred on behalf of the Company. These transactions were on a normal commercial basis.

8. <u>GOING CONCERN</u>

These financial statements are presented on a going concern basis and reliant on neither the East Christchurch Shirley Cricket Club Inc. and the Shirley Rugby Football Club Inc. will seek the repayment of their interest free advances within the next twelve month period.

9. SPONSORSHIP / DONATIONS IN KIND

Donated goods or services are not recognised.

10. SUBSEQUENT EVENTS

There are no material subsequent events (2018: NIL)

11. CONTINGENT LIABILITY

There were no known contingent liabilities at 31/3/2019 (2018: Nil).
